Sapna Infoway Pvt Ltd (here-in-after referred to as 'Company') having its registered office at 3rd main road, Gandhinagar, Bangalore 560009 is organizing the "India Quiz Championship", a quiz-based contest, open for participation by school students studying in Classes 6-10 (here-in-after referred to as the "Quiz").

The IQC registration will start on the 24th of November 2021 and will end on the 3rd of Feb 2022.

Trademark & Registration

India Quiz Championship – Hunt for India's Young Genius is a registered trademark and copyright name under Sapna Infoway Pvt limited. At no given point it should be used or reused in any form or medium without the consent of the Company Sapna Infoway Pvt Ltd.

Eligibility

The Quiz will be open for participation by school students studying in Classes 6-10, in the academic year 2021-22.

Each contestant shall submit requisite proof, either at the time of Registration (*defined herein below*) or at any other stage of the Quiz, as may be deemed appropriate by the Company, regarding his / her age and his / her enrollment in a recognized school located in India/Out of India, along with other necessary and requisite

documents in support thereof. For the sake of clarity, any contestant not meeting the above stated criteria and/or not submitting the requisite proof/information, shall be disqualified from participating in the Quiz.

Process of Registration

The interested students (here-in-after referred to as the “contestants”) who meet the aforesaid eligibility criteria need to register using the link created on the website www.indiaqc.in

Format of the Quiz

The Company will conduct the preliminary rounds on the moodle platform and the subsequent rounds in the digital platform.

1)Round 1- Prelims1

2)Round 2- Prelims 2 - Top 100 from round 1 get selected for Prelims Round2

3)Round 3-National SemiFinals - Top 12 based on round 2 scores will move to the National Semi-Finals

4)Round 4 - National Finale - Top 6 based on round 3 will compete in the Grand Finale

The duration of each prelim round 15/30 min and the Company intends to conduct 2 prelims.

The date, time and duration of the online quizzes shall be decided solely by the Company and shall be intimated to the contestants.

It is hereby clarified that in the eventuality a contestant does not participate in the prelims, he/she will not qualify for the Semifinals/Final Rounds.

It is further clarified, that the entry in the Quiz will remain open until one (1) week before the date of prelims.

Quiz for a Cause

India Quiz Championship is a Quiz for a cause and any proceeds will be termed as a Donation exempt u/s 80G of Income Tax & will be contributed directly to the partner NGO -Shrimad Rajchandra Aatma Tatva Research Centre.

Shrimad Rajchandra Aatma Tatva Research Centre established in 2004 in India, is a registered Charitable Trust , exempt u/s 80G of Income Tax Act, 1961 having a registered No. E-19123

General Terms & Conditions

- i. There is a fee of Rs 199/- for early birds (until 15th Dec 2021) as the registration charge for participating in the quiz contest per student. A fee of Rs 299/- will be charged for registration after 15th Dec 2021.
- ii. All fee prices are inclusive of GST of 18%
- iii. Once confirmed, ticket sales are final. No refunds, exchanges or cancellations are available except as required by law
- iv. If the participant/student does not turn up for the Prelims round 1, no refund will be given/entertained.
- v. Tickets are sold on behalf of the Company responsible for presenting the event and subject to the conditions applicable to the event and/or the venue where the event is presented
- vi. The right is reserved to charge a fee for the replacement of tickets.
- vii. The right of admission is reserved by the Company management.
- viii. Late arrival may result in non-admittance to the Quiz
- ix. The right is reserved to add, withdraw, reschedule or substitute the Quiz programs, prices, venues, & digital platform
- x. Tickets must not be re-sold or offered for re-sale at a premium (including via online auction sites) either by the original purchaser or any subsequent bearer. If a ticket is sold in breach of this condition, the ticket may be cancelled without a refund and the bearer of the ticket may be refused admission. The Company reserves the right to cancel any tickets purchased that are suspected of being used in this way. Scalping warning: The resale of tickets in certain circumstances is governed by ticket sales legislation and may attract criminal penalties
- xi. For all foreign participants (schools/students outside of India and

NRI's) the fee for participation is USD5 per student(Inclusive of 18% GST)

- xii. Since the place of supply of services is in India, **GST shall have to be charged even if the receipt is in USD** since all the conditions of zero rated supplies are not fulfilled.
- xiii. All registration proceeds goes towards upliftment of rural education in India through NGO Shrimad Rajchandra Aatma Tatva Research Centre
- xiv. From the ticket revenue as generated, The Company will make a donation towards NGO Shrimad Rajchandra Aatma Tatva Research Centre(Regn. No. E-19123) after removing GST and other operational expenses.
- xv. Registration by filling the entry form on-line along with parental consent shall be deemed as unconditional and unqualified acceptance of these 'Terms and Conditions'. However, it is clarified here, that registration does not guarantee the confirmed participation of any contestant for the Quiz. The Company may, in its sole discretion, either select or reject any entry for participation in the Quiz.
- xvi. If at any time during the Quiz, the details furnished by the contestant in the entry form are found to be incorrect or incomplete, the Company shall have the right to disqualify such contestant, without any liability, whatsoever.
- xvii. The Company shall have no responsibility to provide any equipment, connectivity including broadband connectivity to enable the contestant to participate in the Quiz. All such expenses, charges and costs thereto shall be borne by the parent of the contestant.
- xviii. The Company shall have, at all times, the unfettered right to add, alter or modify the 'Terms and Conditions' hereto including *inter-alia* the mode of participation, the format of the on-line or off-line quiz or the written test etc. without any prior notice and/or intimation to the

contestants.

- xix. The Company shall also have the right to withdraw the "IQC" at any time prior to the start of the Quiz or thereafter, in its sole discretion, without incurring any liability whatsoever to any contestant who might have participated in the Quiz prior to such withdrawal.
- xx. The participation in the Quiz does not imply or entitle any contestant to claim any prize, reward or any other consideration, monetary or otherwise.
- xxi. The Company may award the winners of the Final Round by way of Scholarship or Monetary reward. The value of the Scholarship and the Monetary reward shall be determined by the Company in its sole and absolute discretion. Any implication under the same will be governed by Tax laws and necessary tax deductions will be made before disbursement of the amounts.
- xxii. The Company may also give participation certificates to all the participants of Prelims round 1 and further subsequent rounds of the Quiz. Please note, those who have registered but not turned up for the Prelims round 1, the participation certificate will not be given.
- xxiii. The Company may publicize the Quiz and may also use the contestant's data filled in the form, photograph, video of the contestant or the contestant's comments etc. recorded during or after the Quiz, for advertisement and promotional purposes, in any media in India or otherwise. Participation in the contest by completing the registration formalities and shall be deemed as permission by the parent of the contestant, without any compensation, for the aforesaid purpose.

It is further understood that all the 'Intellectual Property' in any such image, video, voice recording etc., shall vest solely with the Company and shall be available with the Company for exploitation throughout the world for perpetuity.

- xxiv. The Company may request the winner of the Quiz and / or the other contestants to participate in any on-line or personal interactive session or promotional activity or campaign relating to the 'IQC. The winner and / or the other finalists shall at no point of time refuse or disagree to participate in any such activities and shall endeavor to cooperate with the Company in this respect.
- xxv. The contestant shall have no claim or demand against the Company if the contestant is unable to participate in the contest for any reason, whatsoever, including without limitation, inability to attend the quiz due to any technical/ non-technical reasons or inability to obtain leave of absence from the school etc. No refund will be given to those unable to attend.
- xxvi. It is required that the participant has a laptop with very good internet connectivity to attend this Digital Quiz. Webcam is not necessary. If any issue in acquiring or using the same, the Company is not liable for compensating or refunding the registration fee amount.
- xxvii. The Company shall not be liable for any interruption/cancellation of the Prelims/Semi-final/Final Rounds of the quiz contest, for any reason beyond their control.
- xxviii. Taking part in the Quiz shall be deemed acceptance by the parent of the contestant to receive promotional messages from the Company or any third party authorized by the Company.
- xxix. The Company shall have the sole discretion to prepare the questions for the on-line quizzes and the written test. No claim pertaining to the appropriateness or otherwise of the quiz for the contestants, the correctness of any question or answer thereto shall be entertained by the Company. The Company's decision in this regard shall be final and binding.
- xxx. The Company is empowered and entitled to take a decision on any matter or circumstance not specifically or expressly covered by these

- xxxi. The Company shall in no manner whatsoever be responsible and / or shall not be held liable for any physical or bodily injury or trauma caused to the contestant in relation to attending this Digital Quiz.
- xxxii. Any dispute or claim arising under and pursuant to the IQC shall be subject to the exclusive jurisdictions of the Courts in Bangalore
